

WHEREAS, the Finance Director has recommended entering into an Addendum to Extend the Service Agreement with Sedgwick Claims Management Services, Inc. to serve as third-party administrator for the City's workers' compensation self-insurance program for a period of three (3) years; and

WHEREAS, the base rate for such services will be Fourteen Thousand Sixty-Six Dollars and No/Cents (\$14,066.00), plus claims expenses for the first calendar year, 2020; and

WHEREAS, the base rate for such services for calendar year 2021 will be Fourteen Thousand Four Hundred Eighty-Eight Dollars and No/Cents (\$14,488.00), plus claims expenses; and

WHEREAS, the base rate for such services for calendar year 2022 will be Fourteen Thousand Nine Hundred Twenty-Three Dollars and No/Cents (\$14,923.00), plus claims expenses.

NOW, THEREFORE, BE IT ORDAINED BY THE Council of the City of Beachwood, County of Cuyahoga, and State of Ohio, that:

#### ADDENDUM TO EXTEND THE AGREEMENT FOR AN ADDITIONAL PERIOD

This Addendum to Extend the Agreement for an Additional Period ("Addendum") shall be attached to and made a part of the Service Agreement for Administration of a Claims Program that was effective February 1, 2013 between City of Beachwood ("Client") and Sedgwick Claims Management Services, Inc. ("Sedgwick") (the "Agreement").

In consideration of the Agreement recitals and the mutual covenant and conditions contained herein, the Parties acknowledge that the Agreement is hereby amended as follows:

- 1. The Agreement shall be extended for an additional period commencing February 1, 2020 and ending January 31, 2023.
- 2. Section 9 of the Agreement is amended to modify Sedgwick's contact information to the following:

"General Counsel – Americas, Sedgwick Claims Management Services, Inc., 8125 Sedgwick Way Memphis, TN 38125"

3. Client shall pay Sedgwick the following fees on a life of contract basis for services provided during this additional period:

#### A. <u>Annual Flat Fee</u>:

i. February 1, 2020 and ending January 31, 2021:

Ohio Self-Insured Claims: \$14,066. Ohio State Fund Tail Claims: \$1,000.

ii. February 1, 2021 and ending January 31, 2022:

Ohio Self-Insured Claims: \$14,488. Ohio State Fund Tail Claims: \$700.

iii. February 1, 2022 and ending January 31, 2023:

Ohio Self-Insured Claims: \$14,923. Ohio State Fund Tail Claims: \$500.

If acquisition, divestiture, changes in program requirements, or a fluctuation in claim volume materially impacts program staffing, Sedgwick and Client will agree upon the appropriate flat fee modifications.

- 4. The Medicare Reporting Services Schedule in the Agreement is removed and replaced with the following:

#### MEDICARE REPORTING SERVICES SCHEDULE

To assist the Client in fulfilling Client's Medicare beneficiary reporting obligations under Medicare, Medicaid and State Children's Health Insurance Program Extension Act of 2007 ("MMSEA") Section 111 as set forth in 42 U.S.C. §1395y(b)(7)&(8) and the CMS User Guide ("User Guide") published on March 16, 2009 (and as amended and revised), Sedgwick will perform the following reporting services:

- 1. Sedgwick will electronically interface with the Centers for Medicare and Medicaid Services ("CMS") to capture and report data in the format prescribed by the CMS Specifications.
- 2. Sedgwick will report directly to CMS on behalf of Client as an Account Designee (reporting agent), as such term is defined in the CMS User Guide as amended from time to time by CMS.
- 3. Client will be considered a Responsible Reporting Entity ("RRE") as that term is defined in the User Guide.
  - a. Client will be responsible for maintaining a valid RRE Identification Number as described in the User Guide and as a condition precedent to Sedgwick preforming the duties under this section. Failure to maintain the RRE Identification Number will result in Sedgwick's inability to properly report claims on behalf of the Client. Sedgwick assumes no responsibility for maintaining a valid RRE Identification Number on behalf of the Client.
- 4. Sedgwick will assist Client as follows:
  - a. Sedgwick will electronically interface with the CMS to capture and report data in the format prescribed by the User Guide.
  - b. Sedgwick will report directly to CMS on behalf of the Client as an Account Designee (reporting agent), and/or Account Manager as such term is defined in the User Guide.
  - c. Sedgwick will prepare the required data files and submit them to CMS on a periodic basis in order to properly query and report the appropriate files as defined in the User Guide.
- 5. Sedgwick will be responsible for payment of any and all fines assessed to Client regarding compliance with the Medicare beneficiary reporting requirements of Medicare,

Medicaid and SCHIP Extension Act of 2007 that relate to the negligent acts or omissions of Sedgwick except to the extent that:

- a. Such fines or penalties are the direct result of specific direction given by Client and/or its agent or the actions or omissions of Client and/or its agent; or
- b. Sedgwick did not receive information from Client that is essential to the performance of the duties set forth herein in a timely manner so as to be able to comply with the terms of this Agreement.
- 5. All terms and conditions of the Agreement shall otherwise remain the same, except those terms and conditions which have been added, deleted, or modified by the parties in writing.

#### INTRODUCED BY:

AN ORDINANCE ADOPTING NEW BCO CHAPTER 136 TITLED "PAYMENTS BY FINANCIAL TRANSACTION DEVICE

WHEREAS, it is necessary for the City to establish uniform provisions governing the use of financial transaction devices by City entities for the payment of City expenses.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Beachwood, County of Cuyahoga, and State of Ohio, that:

Section 1: New BCO Chapter 136, titled "Payments by Financial Transaction Device", is hereby enacted to read and provide, in its entirety, as indicated in Exhibit "A" which is attached hereto and incorporated herein by reference.

<u>Section 2</u>: Any other Ordinances or parts thereof in conflict herewith be, and the same hereby are, repealed to the extent of the conflict and all Ordinances not amended by this Ordinance shall remain in full force and effect.

Section 3: It is found and determined that all formal actions and deliberations of Council and its committees, relating to the passage of this legislation that resulted in formal action were in meetings open to the public where required by Chapter 105, Codified Ordinances of the City.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date permitted by law.

#### Exhibit A CHAPTER 136 Payments by Financial Transaction Device

#### **136.01 DEFINITIONS**

As used in this section:

(A) "City Entity" or "City entity" includes the City and any officers, officials, departments, agencies, courts, boards, commissions, committees, organizations, corporations, or any other City Entity established by or pursuant to the Charter of the City of Beachwood, Ohio or Ohio law.

(B) "City Expense" or "City expense" shall be interpreted broadly, and it shall include, without limitation, any and all fees, costs, taxes, assessments, fines, penalties, payments, or any other expense owed to or collected by any City Entity.

(C) "Financial Transaction Device" or "Financial transaction device" or "financial transaction device" includes credit card, debit card, charge card, prepaid or stored value cards, automated clearinghouse network card, debit, or e-check entry that includes, but is not limited to, accounts receivable and internet-initiated point of purchase, and telephone-initiated applications or any other device or method for making an electronic payment or transfer of funds.

(D) "Financial Transaction Provider" or "Financial transaction provider" or "financial transaction provider" includes a financial institution, issuer of financial transaction devices, or processor of financial transaction devices to accept, take, and/or process a financial transaction device.

(E) "Associated Fee" or "associated fee" includes, without limitation, any nonrefundable surcharge, nonrefundable convenience fee or other fee, or any other refundable or nonrefundable fee that is assessed by a City entity or a financial transaction provider in connection with the processing of a City fee by financial transaction device.

#### **136.02 PAYMENT OF EXPENSES BY FINANCIAL TRANSACTION DEVICES**

(A) City entities are authorized to accept and require payment for City expenses by financial transaction devices and may impose associated fees to be paid either directly to the City entity or the financial transaction provider. City entities shall, as practicable, obtain approval from and coordinate their use of financial transaction devices with the Finance Director to ensure all protocol is followed and to avoid the duplication of services.

(B) A non-refundable associated fee of Four Dollars and No/Cents (\$4.00) or Four Percent (4%), whichever is more, will be imposed on all financial transaction devices.

(C) City entities shall notify all customers that the associated fee is being imposed and allow an "opt out" for the transaction if they choose not to pay the fee.

(D) Every City entity accepting or otherwise mandating payments by a financial transaction device shall clearly post a schedule of its fees, including any associated fees, in the City entity's office and on its website. If the fee is non-refundable, the posting shall include a notice that the associated fees are non-refundable.

#### **136.03 DISHONORED OR RETURNED PAYMENTS**

(A) In the event that a payment is made by a financial transaction device and the payment is returned or dishonored for any reason, the payer shall be liable to the City entity for banking charges, legal fees, or other expenses incurred by the City entity in collecting the returned or dishonored payment.

(B) No person making any payment by financial transaction device to a City entity shall be relieved from liability for the underlying obligation except to the extent that the City entity realizes final payment of the underlying obligation in cash or its equivalent. If final payment is not made by the

financial transaction device issuer or other guarantor of payment in the transaction, the underlying obligation shall survive and the City entity shall retain all remedies for enforcement that would have applied if the transaction had not occurred.

(C) The remedies and procedures provided in this section are in addition to any other available civil or criminal remedies provided by law.

#### **136.04 CONTRACT WITH FINANCIAL TRANSACTION PROVIDERS**

All contracts or agreements with financial transaction providers pursuant to this Chapter shall be reviewed and approved by the appropriate approval authority depending on the monetary threshold of each contract or agreement in accordance with Beachwood Codified Ordinances. This section may not be interpreted to require additional approval of any existing contracts or agreements for the payment of City expenses by financial transaction devices, including any associated fees thereunder, which are hereby retroactively ratified.

#### **136.05 IMMUNITY OF CITY OFFICIALS AND EMPLOYEES**

A City official or employee who accepts a financial transaction device payment in accordance with this Chapter, court order, or Ohio law shall be immune from persona liability for the final collection of such payments.

SUBJECT: Legislation: Sale of Police Vehicles

It has been decided that having four police motorcycles is unnecessary due to lack of riders and lack of use. We are planning to keep one of the motorcycles since Officer Kemer and Officer Piro do still ride.

Research has been conducted and it was discovered that Harley Davidson police package motorcycles are not specifically listed in valuation manuals. However, Officer Kemer was able to poll dealers and determine that values can range from \$16,000 to \$16,500 with the components they came with from the dealer. A new 2020 motorcycle would cost around \$18,500. We customized our units with about \$4,000 worth of equipment (including installation) beyond what came with the original police package.

There has been interest from other agencies in the three motorcycles we wish to dispose of. In fact, the City of Eastlake has approved the purchase of one of them already. I have conferred with Mr. Heiser, Mr. Forester and Off. Kemer and it was decided that the area of \$18,000 is a reasonable amount to obtain for each motorcycle with the added equipment attached. I respectfully request that city council be asked to approve disposing of the three motorcycles listed below for amounts approved by Mr. Heiser.


