AN ORDINANCE AUTHORIZING A JOB CREATION INCENTIVE GRANT FOR CURRENT LIGHTING EMPLOYEECO, LLC; AND DECLARING AN EMERGENCY

WHEREAS, the retention and creation of jobs and employment opportunities is integral to the continued economic health of the City of Beachwood, Ohio, (the "City") and its citizens; and

WHEREAS, Article XVIII, Section 3 of the Ohio Constitution gives municipalities the authority to exercise all powers of local self-government and to adopt and enforce within their limits such local police, sanitary and other similar regulations as are not in conflict with general laws; and

WHEREAS, Article I of the Charter of the City provides that the City shall have all powers that may lawfully be possessed or exercised by any city under the Constitution and laws of the State of Ohio and the Constitution and laws of the United States; and

WHEREAS, the use of governmental resources for the promotion of economic development in the community is in the public interest and is a proper exercise of municipal powers pursuant to Article VIII, Section 13 of the Ohio Constitution; and

WHEREAS, by Ordinance No. 2013-10, as amended by Ordinance No. 2021-61, the City authorized a Job Creation Incentive Grant Program to provide incentives to businesses to retain, create and expand employment opportunities within the City without utilizing tax revenues or impacting negatively upon the local school system; and

WHEREAS, the Economic Development Director has requested that a Job Creation Incentive Grant be given to Current Lighting EmployeeCo, LLC ("Current" or the "Company") a lighting and lighting controls company that is moving headquarter operations to 23550 Commerce Park, within the City; and

WHEREAS, upon occupancy, the Company would relocate approximately 115 existing employees, with approximately \$14.5 million of associated annual payroll, to the City; and

WHEREAS, for ten years after the date of the Company moving to the City, the Company would maintain approximately 115 jobs, with an estimated annual payroll of approximately \$14.5 million.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Beachwood, County of Cuyahoga, and State of Ohio that:

Section 1: Pursuant to Article VIII, Section 13 and Article XVIII, Section 3 of the Ohio Constitution, this Council hereby authorizes a Job Creation Incentive Grant to Current whereby 50% of the City's share of all municipal income taxes withheld from Current employees and paid to the City, are rebated to Current for a period of ten (10) years, beginning with the employee payroll for calendar year 2022, with the first year of the grant to be paid in 2023 and as more fully described in the Agreement.

Section 2: Council hereby authorizes funding for the Job Creation Incentive Grant from the following non-tax revenue sources: interest income, permit fees, activity fees, service charges, and tax incentive application and monitoring fees.

Section 3: Council hereby authorizes the Mayor, for and in the name of this City, to execute and deliver an Agreement to provide for the Job Creation Incentive Grant consistent with this ordinance. This Council further hereby authorizes the Mayor, the Economic Development Director, the Finance Director, the City Law Director, and other appropriate officers of the City, to sign those instruments and make those arrangements as are necessary carry out the purposes of this ordinance.

Section 4: It is found and determined that all formal actions and deliberations of Council and its committees relating to the passage of this legislation that resulted in formal action were in meetings open to the public where required by Chapter 105 of the Codified Ordinances of the City.

Section 5: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare; and for the further reason that the award of this Job Creation Incentive Grant is necessary to create and retain jobs in the City of Beachwood.

WHEREFORE, this Ordinance shall be in full force and effect from and after the earliest date permitted by law.

#### **WITNESSED:**

WHEREAS, the retention and creation of jobs and employment opportunities is integral to the continued economic health of the City and its citizens; and

WHEREAS, Article XVIII, Section 3 of the Ohio Constitution gives municipalities the authority to exercise all powers of local self-government and to adopt and enforce within their limits such local police, sanitary and other similar regulations as are not in conflict with general laws; and

WHEREAS, Article I of the Charter of the City provides that the City shall have all powers that may lawfully be possessed or exercised by any city under the Constitution and laws of the State of Ohio and the Constitution and laws of the United States; and

**WHEREAS**, the use of governmental resources for the promotion of economic development in the community is in the public interest and is a proper exercise of municipal powers pursuant to Article VIII, Section 13 of the Ohio Constitution; and

WHEREAS, the Company, conditioned upon the granting by the City of certain economic development incentives as set forth in this Agreement, will relocate approximately 115 jobs with an annual payroll of approximately \$14,500,000.00 to 23550 Commerce Park, within the City (the "Site"); and

WHEREAS, to promote economic development in the community, the City Council of the City approved (i) Ordinance No. 2021-[\_\_] granting the Company a Job Creation Occupancy Grant, (ii) Ordinance No. 2021-[\_\_] granting the Company a rebate of certain permitting fees and (iii) Ordinance No. 2021-[\_\_] granting the Company a Job Creation Incentive Grant, all pursuant to the terms of this Agreement; and

**WHEREAS**, the Parties desire to memorialize their understanding and agreements with respect to such cooperation.

**NOW THEREFORE**, in exchange for the mutual commitments and obligations contained herein, the Parties agree as set forth below:

Section 1. Company's Commitments to the City. The Company will relocate its headquarter operations to the Site, which will include at least one hundred and fifteen (115) employees with at least an annual payroll of \$14,500,000.00 no later than thirty (30) days after the issuance of the occupancy permit of the Site (the "Job Creation"). The Company shall maintain the Job Creation within the City, pursuant to the terms of this Agreement. In the event the Company does not maintain the Job Creation, the Company shall return certain payments received from the City pursuant to the terms of this Agreement.

#### Section 2. City's Commitments to the Company.

- **A. Job Creation Occupancy Grant.** Within thirty (30) days of the issuance of a certificate of occupancy for the Site and the intended relocation of the headquarter operations of the Company to the Site, the City shall pay \$500,000.00 to Lighting Solutions (the "Occupancy Grant").
- **B.** Rebate of Certain Permitting Fees. Within thirty (30) days of the issuance of a certificate of occupancy for the Site and the intended relocation of the headquarter operations of the Company to the Site, the City shall pay to Lighting Solutions an amount equal to the amount paid to and received by the City in permitting fees for the Site, up to and not to exceed \$500,000.00 (the "Fee Rebate").
- C. Job Creation Incentive Grant. The City shall pay to Lighting EmployeeCo an amount equal to fifty percent (50%) of all municipal income tax withheld from Company employees at the Site and paid to the City in a calendar year ("Annual Payroll Taxes"), for a period of ten (10) years beginning with the employee payroll for calendar year 2022, with the first year of the grant to be paid annually starting in 2023 (the "Incentive Grant"). For the avoidance of doubt, the Parties intend for the Incentive Grant to apply for ten (10) full years (120 months), meaning in the first and final year of this Agreement a partial calendar year payment may be due.

The amount of the Incentive Grant will be calculated annually based on the Company's performance in meeting its employee payroll projections of at least \$14,500,000.00 for the previous year. The company must achieve at least seventy-five percent (75%) of the employee payroll for the previous year in order to receive any Incentive Grant benefits and the Incentive Grant may be reduced in a particular year according to the schedule below:

For purposes of calculating the amount of the Incentive Grant each year, annual payroll includes all wages, salaries, bonuses, cash incentive and any other cash compensation paid to Company employees at the Site. For clarity, annual payroll includes any payments by the Company to Company employees and subject to taxation by the City.

**Section 3.** Claw Back Provisions. If Company fails to maintain an annual payroll of \$5,000,000.00 or more at the Site for a period of ten years, Company shall pay to City a percentage of the Occupancy Grant and Fee Rebate paid to Company based on the table below.

- **Section 4. Annual Reporting.** Upon the City's request and on forms provided by the City, the Company must submit an annual Job Creation Grant report documenting new employment and payroll. This report will be required annually during each year a grant is awarded pursuant to this Agreement. A \$250.00 administrative fee shall be required with submission of each annual report. The annual performance reports will be reviewed by the City's Director of Building and Community Development and the Finance Director. An annual report will be prepared by the Director of Building and Community Development and presented to the Mayor and City Council.
- **Section 5.** Successors and Assigns. This Agreement shall inure to the benefit of and be binding upon the respective successors and assigns (including successive, as well as immediate, successors and assignees) of the Parties. The Company may not assign this Agreement to any person without the written consent of the City, which consent will not be unreasonably withheld.
- **Section 6.** Governing Law and Forum. This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio. All claims, counterclaims, disputes and other matters in question between the City, its agents and employees, and the Company, their contractors, subcontractors and agents arising out of or relating to this agreement or its breach will be decided in a court of competent jurisdiction within the County of Cuyahoga, State of Ohio.
- **Section 7. Severability.** Any provisions of this Agreement are severable and in the event that one or more of the provisions are found to be inconsistent with legal requirements upon any party, and therefore unenforceable, the remaining provisions shall remain in full force and effect.
- **Section 8. No Personal Liability.** All covenants, obligations and agreements of the Parties contained in this Agreement shall be effective to the extent authorized and permitted by applicable law. No such covenant, obligation or agreement shall be deemed to be a covenant, obligation or agreement of any present or future member, officer, agent or employee of the City or the Company other than in his or her official capacity, and neither the members of the legislative body of the City nor any City or Company official executing this Agreement shall be liable personally under this Agreement or be subject to any personal liability or accountability by reason of the execution thereof or by reason of the covenants, obligations or agreements of the City and the Company contained in this Agreement.
- **Section 9. Duplicate Originals.** This Agreement may be executed in one or more counterparts, each of which shall be deemed to be a duplicate original, but all of which, taken together, shall constitute a single instrument.
- **Section 10. Headings.** The headings contained in this Agreement are included only for convenience of reference and do not define, limit, explain or modify this Agreement or its interpretation, construction or meaning and are in no way to be construed as a part of this Agreement.

**Section 11. Termination.** If the Company does not move its headquarter operations to the Site within one year of City Council's approval, City Council may terminate this Agreement upon recommendation of the Director of Building and Community Development. If the Company fails to meet an annual payroll of \$10,875,000.00 in three (3) consecutive years at any time during the term of this Agreement, the City may terminate this Agreement and any amounts due to the City from the Company pursuant to this Agreement shall be repaid to the City.

**Section 12.** Term. This Agreement will expire ten (10) years after the first Incentive Grant payment pursuant to this Agreement.

AN ORDINANCE AUTHORIZING A REBATE OF CERTAIN PERMITING FEES TO CURRENT LIGHTING SOLUTIONS, LLC IN CONNECTION WITH JOB CREATION; AND DECLARING AN EMERGENCY

WHEREAS, the retention and creation of jobs and employment opportunities is integral to the continued economic health of the City of Beachwood, Ohio, (the "City") and its citizens; and

WHEREAS, Article XVIII, Section 3 of the Ohio Constitution gives municipalities the authority to exercise all powers of local self-government and to adopt and enforce within their limits such local police, sanitary and other similar regulations as are not in conflict with general laws; and

WHEREAS, Article I of the Charter of the City provides that the City shall have all powers that may lawfully be possessed or exercised by any city under the Constitution and laws of the State of Ohio and the Constitution and laws of the United States; and

WHEREAS, the use of governmental resources for the promotion of economic development in the community is in the public interest and is a proper exercise of municipal powers pursuant to Article VIII, Section 13 of the Ohio Constitution; and

WHEREAS, ICP, LLC ("ICP") has certain rights to the property located at 23550 Commerce Park within the City (the "Site") and intends to enter into a lease with Current Lighting Solutions, LLC ("Current"), which will result in the creation of jobs and associated annual payroll to the City; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Beachwood, County of Cuyahoga, and State of Ohio that:

Section 1: Pursuant to Article VIII, Section 13 and Article XVIII, Section 3 of the Ohio Constitution, this Council hereby authorizes the permitting fees paid to the City in connection with the improvements at the Site be rebated to Current, in an amount up to \$500,000.00.

Section 2: Council hereby authorizes funding for the permitting fee rebate from the following non-tax revenue sources: interest income, permit fees, activity fees, service charges, and tax incentive application and monitoring fees.

Section 3: Council hereby authorizes the Mayor, for and in the name of this City, to execute any necessary agreements consistent with this ordinance. This Council further hereby authorizes the Mayor, the Economic Development Director, the City Law Director, and other appropriate officers of the City, to sign those instruments and make those arrangements as are necessary carry out the purposes of this ordinance.

Section 4: It is found and determined that all formal actions and deliberations of Council and its committees relating to the passage of this legislation that resulted in formal action were in meetings open to the public where required by Chapter 105 of the Codified Ordinances of the City.

Section 5: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare; and for the further reason that the rebate of the permit fees is necessary to create and retain jobs in the City of Beachwood.

WHEREFORE, this Ordinance shall be in full force and effect from and after the earliest date permitted by law.







RE: RenoSys PVC Pool Membrane

Attached is a quote from RenoSys Co. for the installation of a PVC Pool Membrane for the Main Pool and Baby Pool, and a PVC Pool Deck Surfacing for the locker rooms, bathrooms, and comfort station. The 60 mil PVC membrane is one-of-a-kind and a Sole Source material (see attached) and requires no bidding. The pool was scheduled to be sandblasted, caulked, and painted this fall. The quote came back at \$110,000. The city has already spent approximately \$175,000 over the past 15 years to paint, patch, etc.

The total cost of the project is \$240,255. Please see the attached breakdown on the quote.

Because of how our Spring weather is, it would be awfully difficult to get this product installed in April and May before the pool opens. There is a 3-4 lead time on ordering the product and then a 5-6 week installation time. The installation must take place when air temperatures are higher than 40 degrees. Therefore, it is my recommendation that the project take place this Fall.

No amendment appropriation is necessary as there are several projects that didn't occur this year that can cover the expense.

I would like to request that bidding be waived on this product and that the attached quote be forwarded to Council for approval.

#### **Product Facts:**

The RenoSys pool liner is made from flexible 60 mil commercial grade PVC, so it is incredibly effective at resisting leaks and tearing. The PVC membrane has an industry leading 10 year service warranty as standard. This low maintenance pool interior does not require regular resurfacing and is finally an end to constant painting and plastering.

The zero depth area would have an anti-slip surface and be much more comfortable than concrete. The pool would look virtually brand new and not need to be painted for 10-15 years (or a new RenoSys Membrane). Additionally, RenoSys would remove the 1" tiles at the water level that are constantly falling off and being picked off and cover them with the membrane.

The PVC Pool Deck surfacing has a deep embossed texture that is aggressive enough to provide traction while still being comfortable under foot. The Deck Surfacing will eliminate the need for patching, painting, and the blue 'mats' that are currently in the locker rooms. The non-porous anti-microbial formulation and slip-resistant surface texture results in more hygienic and safer conditions. The Deck Surfacing does not require any special equipment or solutions to clean, and can withstand extreme conditions and is formulated with UV inhibitors to protect from fading.

#### Specifications and Contract Conditions for a RenoSys PVC Membrane System Installed

Primary pool lining membrane shall be a flexible 60 mit double pty PVC material UV stabilized, and reinforced with internal polyester webbing. The material shall be formulated using anti-fungal agents and manufactured specifically for use in the commercial pool environments. Clients purchasing RenoSys materials are solely responsible for determining the suitability and compatibility of the RenoSys products for their application. RenoSys will not be responsible for materials reaction to water, substrate, soil or pool chemicals

Geo-textile fabric underlayment of 100% polyester approximately 150 mils thick to isolate and separate the RenoSys PVC Membrane from the pool wall and floor. Depending on field conditions the use of a factory applied of equivalent quality Felt-back membrane product will be utilized. Geo-textile is an "if required" product and may not be applicable on every project. RenoSys shall be the sole agent to determine if Geo-Textile is necessary for your project.

Provide as required PVC coated RenoSys Metal to make for a satisfactory installation. Sanitizing agents to be applied as required onto the pool substrate to discourage microbial growth under the membrane system. 

### Mayor,

Over the course of the summer, the cooling portion of the HVAC System for the Gun Range Area failed and is need of replacement. The heating unit portion of this unit was installed in 1987 and to avoid a shut-down of this area during the winter months, it is my recommendation that we replace both units.

We have received 3 quotes to replace the HVAC unit for the Gun Range. The lowest price was submitted by Smith & OBY with a total cost of \$84,945.00. The scope of this project is the removal and replacement of the roof top unit along with the removal and replacement of the Reznor unit located inside of the police garage. Lead time for this project is 8-10 weeks.
